## QVC, Inc. DAVID'S ROAD TRIP CONTEST OFFICIAL RULES

QVC, Inc. ("Sponsor") is sponsoring the David's Road Trip Contest ("Contest").

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. MUST BE 18 YEARS OR OLDER TO ENTER. VOID WHERE PROHIBITED.

By entering this Contest, entrants agree to abide by all terms of these Official Rules and the decisions of the Sponsor whose decisions shall be final and binding.

- ELIGIBILITY: The Contest is open to legal residents of the United States and District of Columbia, excluding Rhode Island, who are 18 years or older as of date of entry.

4. **WINNER DETERMINATION:** At the conclusion of the Contest Period, a judging panel, consisting of designated representitives of Sponsor, will select eight (8) finalists from among all eligible Submissions. One (1) winner will be selected from among the eight (8) finalists to attend the ITKWD Weekend in August. Judging will be based on the following criteria: Relevance (50%) and Creativity (50%). The Sumbission with the highest overall score based on judging will be deemed the Winner. In the event of a tie, the entry from among all such tied entries with the higher/highest score in Relevance will be deemed the winning entry.

The determination of the Winner will be made by Sponsor in its sole discretion. Sponsor's determination is final and cannot be appealed.
