**OFFICIAL RULES**

**QVC, Inc. ("Sponsor") is sponsoring the In the Kitchen with David Pinterest Sweepstakes ("Sweepstakes"). This Sweepstakes is not sponsored, endorsed or administered by, or associated with, Pinterest.**

Step 2: Pin a one-pot meal recipe using #GetCooking

Step 3: Enter your email address in the space provided on the entry form.

Step 4: Click "Submit & Pin" to pin the image to any board on your Pinterest profile.

**By completing the Online Entry or submitting a Mail Entry, you are signifying that you have read, understand and agree to these Official Rules.**

**Limit of one (1) entry per person during the entry period either by Mail or Online. Any person who attempts to participate with entries in excess of these entry limitations will be disqualified.** Any other attempted form of Sweepstakes entry is void. Any person who attempts to participate under multiple identities or uses any device or artifice to enter in excess of this entry limitation will be disqualified; use of programmed, automated or like means of entry is prohibited.
