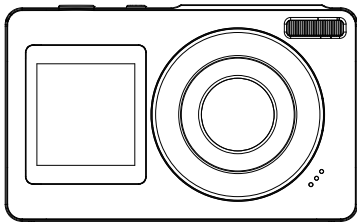

## WARNING

---

To reduce the risk of fire or electric shock,

1.) Do not expose the unit to rain or moisture.

2.) Do not place objects filled with liquids, such as vases, on the apparatus.

Do not expose the batteries to excessive heat such as sunshine, fire or the like.

Do not ingest battery, chemical burn hazard. The remote control contains a coin/button cell battery. If the coin/button cell battery is

swallowed, it can cause severe internal burns in just 2 hours and can lead to death.

Keep new and used batteries away from children. If the battery compartment does not close securely, stop using the product and keep it away from children.

If you think batteries might have been swallowed or placed inside any part of body, seek immediate medical attention.

## CAUTION

---

If the battery is mishandled, the battery pack can burst, cause a fire or even chemical burns.

Observe the following cautions.

Do not disassemble.

Do not crush and do not expose the battery pack to any shock or force such as hammering, dropping or stepping on it.

Do not short circuit and do not allow metal objects to come onto contact with the battery terminals.

Do not expose to high temperature above 60°C (140°F) such as in direct sunlight or in a car parked in the sun.

Do not incinerate or dispose of in fire.

Do not handle damaged or leaking lithium ion batteries.

Keep the battery pack out of the reach of small children.

Keep the batter pack dry.

Replace the battery with the specified type only. Otherwise, burst, fire or injury may result.

Dispose of used batteries according to the instruction.

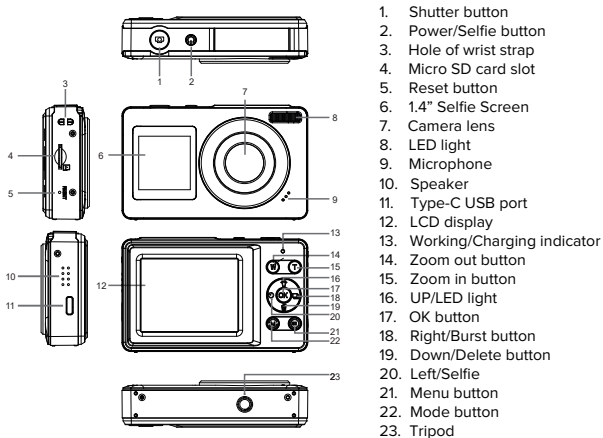
Use a nearby wall outlet(wall socket) when using the AC Adapter/Battery charger. If any malfunction occurs, disconnect the plug from the wall outlet (wall socket) immediately to disconnect from the power source. If you use the product with a charge lamp, note that the product is not disconnected from the power source even when the lamp turns on.

Do not use the AC adapter/Battery charger placed in a narrow space, such as between a wall and furniture.

If static electricity or electromagnetism cause data transfer to discontinue midway (fair), restart the application or disconnect and connect the communication cable (USB, etc.) again.

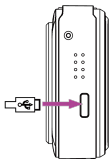


## Charging the battery

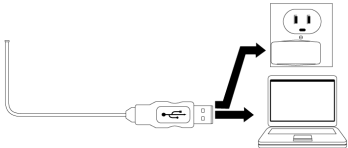
---

Open the battery cover and insert the battery in the direction as the shown of following picture, then close the battery cover. Then charge your camera as below steps:

1. Insert one end of the included USB cable into the USB port on your camera.



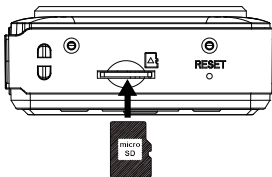
2. Insert one end of the included USB cable into the USB port of a computer or a suitable 5V/1A USB charging adapter (not included).



**NOTE:** A charging indicator light will illuminate while charging and then turn off once charging is complete.

## Insert and format the memory card

The camera with an internal memory that support to save up to 100 photos in VGA resolution. For higher resolution photo and video, a class 4 or higher speed memory card is needed for normal use.

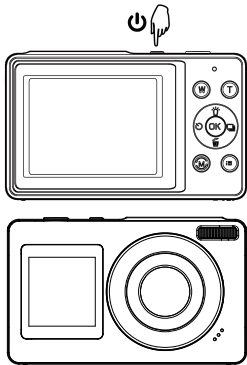


Before turning on your camera, insert a micro SD memory card (not included). The memory card is needed in order to store photos or videos.  
Note: Class 4 or higher micro SD memory cards are supported (up to 64 GB).

# Using the camera

---

## Turning on your camera



Press and hold the Power/Shutter button for approximately 3-4 seconds to power on or power off your camera.

Press the power button briefly to enter selfie mode.

Press Power/Selfie button change to selfie display.



## Camera modes

Once the camera is powered on, press the Mode button repeatedly to switch between the camera's different modes.

The camera has three modes:

- **Photo Capture Mode**

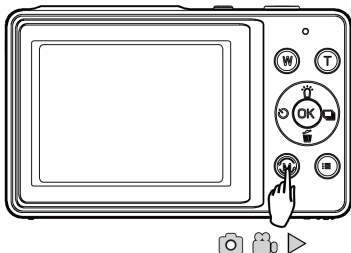
(for capturing photos)

- **Video Capture Mode**

(for recording video)

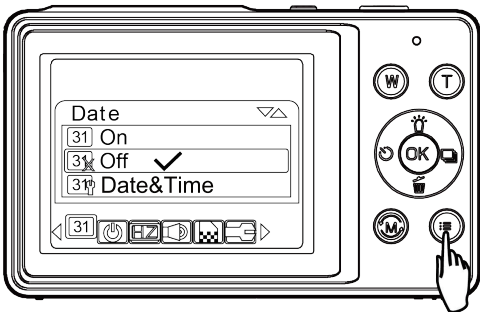
- **Playback Mode**

(for reviewing photos & videos)

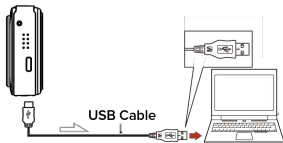

## Connect to computer

Connect the camera to computer is able to transfer the images to computer, also can use the camera as a PC camera.



- **Mass storage mode**

Connect the Type-C USB port of the camera and the USB port of the computer with supplied USB cable. Then turn on the camera, it will enter to MSDC mode. The computer will display the memory card disk of the camera, and you can transfer the images from memory card to the computer.

- **PC camera mode**

Connect the Type-C USB port of the camera and the USB port of the computer with supplied USB cable. Then press and hold the Shutter and Power button together, release the buttons while the camera turning on. The camera can be used as a webcam, live streaming, etc.
