

Ten-Year Full Warranty

This warranty extends to Original Consumers and subsequent owners or users of this product. Winston Products, LLC will provide the following remedies in the sequence provided to whatever extent it shall deem necessary to satisfy a proper claim under the Full Warranty:

First, repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore the product to its proper operating condition;

If after a reasonable number of the repair efforts are unsuccessful, then one of the two remedies at the option of the consumer:

1. Replace the product with a direct replacement or with a similar product of equal value deemed by Winston Products, LLC to perform substantially the same function as the original product; or
2. Refund the purchase price of the product. The consumer must be able to present the original receipt of purchase or other proof of purchase.
